Procedure for the admission test

Master Global Public Health

Approval procedure:

- Please apply online to Deggendorf Institute of Technology. The application period is listed on our webpage.
- As an applicant for the Master's degree programme Global Public Health, you qualify with proof of a certified university entrance qualification.
- Please check our study and examination regulations for all the relevant admission requirements.

One of the admission requirements is a minimum of two years relevant work experience, part time can be credited

Informationen on the admission test:

- The application for the admission test must be submitted and uploaded with the application documents in the online application process. You can find the document for the application for the admission test on the homepage and in the online application tool.
- The test is intended to prove the ability to work scientifically and therefore to determine whether the special qualitative requirements for the successful completion of the Master's programme in Global Public Health are met.
- The following criteria are considered for aptitude assessment. :
 - 1. Written test:

The written online test contains questions regarding the recognition and assessment of strategic and international relationships and problems as well as the ability to present and discuss possible solutions. The written test takes place as online-based.

2. Selection interview:

The selection interview contains a technical discussion, your motivation for the master program, your expectations on the master program as well as the reference to your later occupation. You only are invited to the selection interview, if you pass the written exam.

Online-Test

The online test will be proctored by an external service provider and as such will incur a small fee. Payment has to be made with an internationally accepted credit card. In order to take the online test, you must register with ProctorU. You mustn't register with DIT for the online test.

ProctorU is a live online proctoring service that allows you to take your exam from the comfort of your home. ProctorU provides a platform with multi-factor identity verification and end-to-end video recording with AI based behavior flagging. Test-takers are guided through the entire process by a live proctor who can also assist with technical issues. ProctorU is available 24/7; however, you will need to schedule your proctoring session at least 72 hours in advance to avoid any additional on-demand scheduling fees.

In order to use ProctorU, you will need a high-speed internet connection, a webcam (internal or external), a windows or apple Operating System, and a government issued photo id.

At the scheduled day and time of your test, you must login to ProctorU. You will be guided through the next necessary steps and the proctor will unlock the actual admission test. It is crucial that you have your username and password (provided via-mail) at hand.

Once you have started the test, the proctor is unable to pause the clock for any reason. This is why we highly recommend that you ensure that your connection is stable for the duration of the online admission test.

• <u>Result of the written aptitude assessment:</u>

Applicants who obtain 50 per cent are admitted to take part in the selection interview. Applicants with an overall assessment of 50 per cent or less receive a rejection notice.

- <u>Result of the selection interview:</u>
 Applicants who obtain 50 per cent or more points in the interview are admitted, Applicants with an overall assessment of 50 per cent or less receive a rejection notice for the study program. Further Information is available on our webpage.
- The procedure for determining suitability for a specific degree programme is carried out yearly in the summer semester for the following winter semester. Applications for admission to the procedure, together with the application documents, must be submitted to the Deggendorf Institute of Technology in the online application procedure by the end of the application period. The application period is listed on our webpage.
- Applicants who have not provided proof of their course-specific eligibility can re-register for the test once more on the date of the following year. In justified exceptional cases, it

is possible to register for the test at a later date. It is not possible to retake the test at a later date.
