Conditions for Eligible Institutions and Authorised Users, Stand: 01.03.2007

RELATIVE TO THE LICENCE BETWEEN

1 International Union of Crystallography with business address at 2 Abbey Square, Chester CH1 2HU, UK ("the Publisher")

and

2 Technische Informationsbibliothek Hannover, the German National Library for Science and Technology with business address at Welfengarten 1 B, 30167 Hannover ("the Licensee")

1. KEY DEFINITIONS

1.1 In this Licence, the following terms shall have the following meanings:

Eligible Institutions are any of the following types of institutions within Germany: (a) Higher Education Institutions financed either by public or private funding; (b) National, regional and state libraries; (c) Academic specialist libraries mainly financed by public funding; (d) Research institutions mainly financed by public funding; (e) Governmental institutions. In addition, any of the above mentioned types of German institutions abroad are included.

Authorised Users within Eligible Institutions are as follows:

Higher Education Institutions: Students including guest students, Faculty including visiting lecturers, Staff and contractors, Walk-In-Users; Remote Access is included.

Academic Libraries, Research Institutions and Governmental Institutions: Staff, contractors and Walk-In-Users; Remote Access is included for registered users.

Commercial Use Use for the purposes of monetary reward (whether by or for the Licensee or an Authorised User) by means of sale, resale, loan, transfer, hire or other form of exploitation of the Licensed Materials. For the avoidance of doubt, use by the Licensee or by an Authorised User of the Licensed Materials in the course of research funded by a commercial organisation, is not deemed to be Commercial Use. Recovery of costs is not deemed commercial use. The use of Metadata by commercial search machines does not constitute commercial use as long as that Metadata is not sold, lent, distributed otherwise or re-licenced via that search machine or the access to that Metadata on that search machine is exclusively being charged for.

Secure Network A network (whether a standalone network or a virtual network within the Internet) which is only accessible to Authorised Users whose identity is authenticated at the time of log-in and periodically thereafter consistent with current best practice, and whose conduct is subject to regulation by the Eligible Institution.

Server The server, either the Publisher's server or the Licensee's server or a third party server designated by the Publisher, on which the Licensed Materials are mounted and may be accessed.

Licensee's server One or more servers operated by the Licensee, or by relevant special collection field libraries and/or contractors of each of the Eligible Institutions, on which the Licensed Materials are mounted and may be accessed.

Local Hosting The storage and redistribution of some or all of the Licensed Materials on one or more servers operated by the Licensee, or by relevant special collection field libraries and/or contractors of each of the Eligible Institutions in order to give access to those institutions and Authorized Users.

2. USAGE RIGHTS

- 2.1 Authorised Users may, in accordance with the copyright law of Germany and subject to clause 4 below:
- 2.2.1 Search, view, retrieve and display the Licensed Materials on a Secure Network.
- 2.2.2 Electronically save parts of the Licensed Materials for personal use, and to create course packs and electronic reserves for Authorised Users.
- 2.2.3 Print off a copy of individual articles or items of the Licensed Materials.
- 2.2.4 Distribute a copy of individual articles or items of the Licensed Materials in print or electronic form to other Authorised Users.
- 2.2.5 Nothing in this Licence shall in any way exclude, modify or affect any of the Licensee's rights under the copyright laws of Germany.

3. PROHIBITED USES

- 3.1 Neither the Eligible Institutions nor Authorised Users may:
- 3.1.1 remove or alter the authors' names or the Publisher's copyright notices or other means of identification or disclaimers as they appear in the Licensed Materials;
- 3.1.2 systematically make print or electronic copies of multiple extracts of the Licensed Materials for any purpose other than permitted under clauses 3.1.2 and 3.1.3;
- 3.1.3 except as provided in clause 3.1.8, provide, by electronic means, to a user at another library or elsewhere, a retained electronic copy of any part of the Licensed Materials;
- 3.1.4 mount or distribute any part of the Licensed Material on any electronic network, including without limitation the Internet and the World Wide Web, other than for Local Hosting on a Secure Network
- 3.2 Publisher's explicit written permission must be obtained in order to:
- 3.2.1 use all or any part of the Licensed Materials for any Commercial Use;
- 3.2.2 systematically distribute the whole or any part of the Licensed Materials to anyone other than Authorised Users:
- 3.2.3 publish, distribute or make available the Licensed Materials, works based on the Licensed Materials or works which combine them with any other material, other than as permitted in this Licence;
- 3.2.4 alter, abridge, adapt or modify the Licensed Materials, except to the extent necessary to make them perceptible on a computer screen or as otherwise permitted in this Licence, to Authorised Users. For the avoidance of doubt, no alteration of the words or their order is permitted.

4. ELIGIBLE INSTITUTION'S UNDERTAKINGS

- 4.1 The Eligible Institutions shall:
- 4.1.1 ensure that only Authorised Users are permitted access to the Licensed Materials.
- 4.1.2 ensure that all Authorised Users are appropriately notified of the importance of respecting the intellectual property rights in the Licensed Materials and that they are made aware of and undertake to abide by the terms and conditions of this Licence;
- 4.1.3 immediately upon becoming aware of any unauthorised use or other breach, inform the Licensee and the Publisher and take all steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence;

4.1.4 issue passwords or other access information only to Authorised Users and ensure that Authorised Users do not divulge their passwords or other access information to any third party;

4.2 The Eligible Institution agrees to indemnify, defend and hold the Publisher and the Licensee harmless from and against any loss, damage, costs, liability and expenses (including reasonable legal and professional fees) arising out of any claim or legal action taken against the Publisher or Licensee related to or in any way connected with any use of the Licensed Materials by the Eligible Institution or Authorised Users or any failure by the Eligible Institution to perform its obligations in relation to this Licence
