

## ELECTION ANNOUNCEMENT

### **for the election of representatives of students in the Senate, in the Faculty Councils and in the Student Convention of the Deggendorf Institute of Technology on July, 02 and 03, 2024**

According to Art. 48 of the Bavarian Innovation Education Act (BayHIG) the representatives of students in the Senate and the Faculty Councils as well as the other representatives in the Student Convention are reelected by the members of the group to which they belong.

In accordance with the constitution of the Deggendorf Institute of Technology, these committees include, without prejudice to Art. 50 (1) BayHIG, the following group representatives to be elected:

The representatives in the individual, collegial bodies are elected in each case according to the individual, collegial bodies of separate ballots. The tenure of office of the representatives of students in the Senate, Faculty Councils and the Student Convention begins on October 1, 2024 and ends on September 30, 2025.

The exercise of the right to vote depends on the entry in the electoral roll. The electoral roll is available in rooms

and can be viewed from **28 May to 03 June 2024 from 9 a.m. to 2 p.m.**. Those concerned may submit written objections to non-entry or incorrect entry in the electoral roll to the returning officer by **05 June 2024, 4 p.m.** at the latest.

Those entitled to vote shall be invited, during the period from

**02 May to 16 May 2024**

to submit nominations to the returning officer separately for each committee. Nominations must be made in writing. Samples for election nominations are available in the respective Faculty office and on the university's website.

A nomination for the election of the representatives of students in the Senate and for the other representatives of the students in the Student Convention must be signed by at least ten persons, and a nomination for the election of the representatives of students in the Faculty Councils must be signed by at least five persons who are entitled to vote for the respective committee.

When signing the nomination, proposers must state their surname and first name as well as the faculty to which they belong. A person entitled to vote may support only one nomination for election to a collegial body; if someone has signed several nominations, the signature on all nominations is invalid. Nominations that are submitted belatedly are invalid. Only persons who have been included in a valid nomination can be elected.

The number of candidates for a nomination may not exceed three times the number of representatives to be elected. When the student representatives are elected to the faculty councils, the number increases to twice the maximum number of student representatives belonging to the respective student representative body, i.e. to 16.

The name of the individual candidates must be listed on the nomination form and assigned serial numbers. In addition to the surname, the first name and faculty must be indicated. The written declaration of consent of the candidates named in it for candidacy on this nomination must be submitted. A candidate may only be named on one nomination for election to a collegial body.


**Voting will take place on**

**July 02 and 03, 2024 from 9 a.m. to 2 p.m.**

The place of voting shall be notified in an electoral notification. The persons entitled to vote shall receive the voting notifications by e-mail before the date on which the electoral roll is closed.

Voting is also permitted in the form of postal voting. Those entitled to vote who intend to cast their vote in the form of a postal vote must apply to the returning officer for the election documents to be sent or handed out in text form (e.g. in writing using the form provided on the Internet, by e-mail to [wahlen@th-deg.de](mailto:wahlen@th-deg.de)) . The application must be received by the returning officer by 4 p.m. on June 18, 2024, at the latest. If you receive the postal vote documents in person, you can apply for a postal vote until June 25, 2024, 4 p.m. in post office of the Deggendorf Institute of Technology.
